What is an MPA?

Various definitions...

"A clearly defined geographical space, recognized, dedicated and managed, through legal or other effective means, to achieve the long-term conservation of nature with associated ecosystem services and cultural values." - IUCN (2008)



Different types: Multi-use vs. no-take?

Some common characteristics:

- No industrial activities
- Conservation of biodiversity is primary goal (vs. conservation of fish stocks)

Why do we need MPAs?



- increase in species richness
- increase in biomass
- increase in size of fish and shellfish species
- increase in resilience

Marine Ecosystem Services

Biodiversity is not just nice to have – marine ecosystems sustain life on earth (e.g. humans)

Healthy marine ecosystems provide us with free services such as

- Food provision
- Tourism
- Carbon storage
- Coastal protection





Food provision

Predatory fishes have declined by 90% in the past century

THE STOCKS OF angel sharks in Irish waters have declined at an alarming rate over the past 25 years, according to new research.

A study published in 'Endangered Species Research' which analysed angling data over a 40 year period from two angel shark hotspots in Irish waters, Tralee Bay and Clew Bay, revealed that there has been a sharp decline of at least 95% since the 1990s.

Although a member of the shark

family, angel sharks don't have the classic shark shape, but a flatter appearance and a broad snout. Adults can grow up to two-and-a-half metres long.

Until the 60s, they could be found all around the Irish coast – but they were targeting in sport angling competitions during the 60s and 70s.

A global refuge for angel shark remains in the Canary Islands some sharks are still occasionally seen in historical hotspots such as Cardigan Bay in Wales and Tralee Bay, Co, Kerry.

According to Inland Fisheries Inland, it has only recorded 20 angel sharks since 200. This
